RULES AND REGULATIONS FOR LANDSCAPERS:
PLEASE AFFIX PERMIT DECALS TO DRIVERS SIDE REAR BUMPER OF VEHICLE

11. Rules and Regulations to be followed by License:
- (a) The Licensee shall be responsible for the disposal of all yard waste and debris. No Licensee shall place any garbage, refuse cuttings, wood or other materials upon any public highway or public property. All lawn cuttings and debris accumulated from real property located in the Village of East Williston must be removed by the Licensee and disposed of at his/her own cost. **LEAVES MAY NOT BE LEFT IN THE STREET – THEY MUST BE REMOVED BY THE COMMERCIAL LANDSCAPER APPLYING FOR THIS PERMIT.** Failure to remove leaves will result in a fine or suspension of the landscaping license.
 - (b) No Licensee shall scatter or dump any garbage, refuse, cuttings, leaves or other waste material on any public highway or public property. No Licensee shall use any mechanical or electrical power device to cause these items to be scattered on any public highway or public property.
 - (c) The identification permit shall be affixed to and displayed in the drivers side dashboard of each vehicle regularly used in the course of business within the Incorporated Village of East Williston. **THE PERMIT ISSUED MUST BE DISPLAYED AND AVAILABLE TO SHOW THE PROPER AUTHORITIES AT ALL TIMES.**

(d) Other: Refer to this application the accompanying guidelines and Chapter 89 of the Code of the Incorporated Village of East Williston for other rules and regulations to be followed.

(e) Upon approval of this application, a license will be issued which is NON-TRANSFERRABLE.

11. I HAVE READ THIS APPLICATION, THE ACCOMPANYING GUIDELINES AND CHAPTER 89 (WITH REVISIONS) OF THE CODE OF THE INCORPORATED VILLAGE OF EAST WILLISTON, all of which govern landscaping businesses within the Incorporated Village of East Williston

12. Contractors and landscapers are PROHIBITED from conducting ANY work within the Incorporated Village of East Williston on SUNDAYS, AND LEGAL HOLIDAYS, EXCEPT TO PERFORM EMERGENCY WORK.

13. Permitted times of landscaping work and related activities are MONDAY TO FRIDAY, **8:00AM TO 5:00 PM. SATURDAYS FROM 9:00 A.M. TO 5:00 PM ONLY. AGAIN-NO WORK PERMITTED ON SUNDAYS OR LEGAL HOLIDAYS.**
