

**BOARD OF TRUSTEES**  
**INC. VILLAGE OF EAST WILLISTON**  
**REGULAR MEETING**  
**WEDNESDAY, OCTOBER 8, 2014**

Regular Meeting of the Board of Trustees of the Incorporated Village of East Williston was held on Wednesday, October 8, 2014 at 8:00 p.m. at the Village Hall, 2 Prospect Street, East Williston, New York.

There were present: Mayor David E. Tanner, Trustees Bonnie L.S. Parente, Caroline DeBenedittis, Robert M. Vella, Jr., Village Clerk Marie L. Hausner.

Trustee Christopher Siciliano and Village Attorney Jeffrey Blinkoff will be late in coming to the meeting.

On the motion of Trustee Vella, seconded by Trustee DeBenedittis, and with Mayor Tanner and Trustees Parente, DeBenedittis and Vella all voting "aye", the Board approved the minutes of the agenda meeting of September 8, 2014.

On the motion of Trustee Parente, seconded by Trustee DeBenedittis and with Mayor Tanner and Trustees Parente, DeBenedittis, and Vella all voting "aye", the Board unanimously approved the minutes from the agenda meeting of September 29, 2014.

**TRUSTEE REPORTS**

**DEPUTY MAYOR/TRUSTEE BONNIE PARENTE**

Trustee Parente reported that the East Williston Fire Department had responded to two mutual aids to Williston Park during the month.

Trustee Parente also noted that the East Williston Fire Department's 125<sup>th</sup> anniversary celebration will be postponed. Trustee DeBenedittis will elaborate more on this matter in her Recreation Committee report.

The Recreation Committee in conjunction with the East Williston Fire Department have postponed the 125<sup>th</sup> anniversary celebration until next year. Anyone who submitted checks for the tent party will have them returned.

The Recreation Committee will be holding moving night on Friday, October 17<sup>th</sup> showing the movie Hotel Transylvania. Game night will take place on Friday, October 24<sup>th</sup>. Children must be pre-registered to attend.

The Ragamuffin Parade will take place on October 25, 2014 at 2:30pm.

A group will gather to sew pillow cases for pediatric cancer patients on Saturday, November 5<sup>th</sup> from 10am to 3pm.

**TRUSTEE ROBERT M. VELLA, JR.**

Trustee Vella reported that the Justice Court collected a total of \$2,850.00 in fines from 30 violations in September 2014. The violations consisted of 26 parking violations and four moving violations.

The Library’s annual book sale will commence on November 8, 2014 in the Village Hall lobby.

**MAYOR DAVID E. TANNER**

Mayor Tanner announced that the annual Veteran's Day ceremony will take place on the Village Green on Tuesday, November 11, 2014 at 11:15 am.

The Department of Public Works will be replacing street signs and posts in the southwest quadrant. Residents can view the first of the new posts and signs at the corner of East Williston Avenue and Sagamore Avenue. The Village will continue to replace all of the signs by quadrant.

Mayor Tanner asked the clerk to update those present about 8 Sumter Avenue. The clerk stated that the Village and Mr. & Mrs. Muzio are due back in court on October 15<sup>th</sup>. The Muzio's have requested another Order to Show Cause in the Supreme Court to stop the Village from demolishing the buildings on the property. Mr. Blinkoff will be submitting an affirmation toward that end.

Trustee Vella stated that the Muzio's will have to show a measure of proof to the court that the Village cannot demolish the buildings.

Barbara Seixas stated that she was very pleased that the Village installed a new street light to the east of her property on Sumter Avenue, about a year ago.
