**RESOLUTION NO. 2020-7 A RESOLUTION APPROVING THE LOSAP REFERENDUM AS DRAFTED FOR THE BALLOT OF THE ELECTION OF MARCH 18, 2020.**

On the motion of Mayor Parente, seconded by Trustee Dunne, and with Mayor Parente and Trustees Siciliano, Iannone, Dunne and Lark all voting "aye", the Board unanimously approved the LOSAP referendum as drafted for the ballot of the election of March 18, 2020.

### **TRUSTEE JAMES LARK**

Trustee Lark presented the Justice Court Report for February 2020. There were 30 parking, five moving and no village code violations dispensed with in February. Fees collected of \$1,670.00 with \$239.00 in New York State surcharges.

Work on extending the dugout at Devlin Field by the East Williston Little League is nearing completion and will be ready by opening day.

### **MAYOR BONNIE L.S. PARENTE**

Mayor Parente stated that for the upcoming Village election on March 18<sup>th</sup>, the Village will supply individual pens to each voter so no two people will have contact to the pens, and hand sanitizer will be available so help avoid the spread of the Coronavirus.

### **VILLAGE CLERK MARIE HAUSNER**

The following building permits were issued in February 2020: 19 Wheatley Avenue, installation of a central air condition unit. 15 East Williston Avenue, legalize and maintain a cellar and 2<sup>nd</sup> floor renovation. 65 High Street, expand driveway. 79 Bengeyfield Drive, interior alterations and relocate a central air conditioning unit.

The Nassau County Police Department Third Precinct report for January 2020 showed no auto accidents, five aided cases, no reports of burglary, larceny (auto), robbery or

criminal mischief. Two incidents of larceny (other than auto). Ten moving violations and two parking violations were issued.

**RESOLUTION NO. 2020-8 A RESOLUTION SETTING A DATE FOR A TAX LIEN SALE OF ALL UNPAID VILLAGE TAXES FROM THE 2019-2020 FISCAL YEAR FOR APRIL 24, 2020.**

On the motion of Mayor Parente, seconded by Trustee Iannone, and with Mayor Parente and Trustees Siciliano, Iannone, Dunne and Lark all voting "aye", the Board unanimously authorized to set a date for a tax lien sale of all unpaid Village taxes from the 2019-2020 fiscal year for April 24, 2020.

**RESOLUTION NO. 2020-9 A RESOLUTION SETTING A DATE FOR THE BUDGET HEARING FOR THE 2020-2021 FISCAL YEAR FOR APRIL 6, 2020.**

On the motion of Trustee Siciliano, seconded by Trustee Dunne, and with Mayor Parente and Trustees Siciliano, Iannone, Dunne and Lark all voting "aye", the Board unanimously authorized to set a date for the budget hearing for the 2020-2021 fiscal year for April 6, 2020.

The Mayor opened the meeting to residents.

Robert Vella addressed the Board regarding consideration of possible zoning changes within the Village of East Williston.

Some questions recently arose regarding the installation of pools within the Village. He noted that it appeared that there was need to determine on whether some pools cause and encroachment issue where other do not.

If the Board considered changes to the zoning code, it would take the guess work out of zoning board decisions and eliminate the arbitrariness of those decisions rendered.

Michael Guglielmo asked if there was an accounting for monies saved by the Village without costs for snow plowing and sanding during this mild winter.

The Board advised that Treasurer Michael Delury was not present, but that Mr. Guglielmo could call the Village office to obtain that information.

There being no further business, on the motion of Trustee Siciliano, seconded by Trustee Iannone, the meeting was adjourned at 8:35 pm.
